 The Northern Section continues its various outreach and engagement efforts including the development of individual fact sheets. With Peter Gower spearheading this effort, a number of draft fact sheets were collected in mid-December and are currently being edited and prepared for final publication through the Chapter's website. The Northern Section is also continuing its partnership with the College of Business at the University of Nevada, Reno to produce online educational luncheons as part of a "In The Black" speaker series. Three online educational luncheons have been produced as part of this series already with the next one, featuring Dr. LaVonna Blair Lewis from the USC Sol Price School of Public Policy, scheduled for January 5, 2021. The Northern Section will also offer 3.75 AICP CM credits for the College of Business' upcoming Vision 2021: The Nevada Economic Forecast scheduled for January 22, 2021.

 - The Southern Section is preparing to hold a Zoom Planning Advance in mid-January to map out activities for 2021. It's anticipated that all Section Officers and other interested members can share their ideas for holding meaningful events during the year and beyond. Lorenzo: I sent out the Role description in December. Did not get much feedback. I was thinking of adding something about having a minimum number of posts or interventions for carrying out the Role properly. That, or financial aid for APA membership. I would think the role would require at least 1 hour per week, posting pictures on different platforms. Regarding the scholarship, what can we offer someone for Chapter membership with COVID-related hardships? I thought we could waive up to 50-percent of membership fees (National and Chapter) or up to \$500...?

Jared: Perhaps we should send an email blast out for volunteers without an incentive first to see if someone will do this purely on a volunteer basis. As a reminder, we did pass the budget last month with an allocated \$2,000 for membership assistance.

Nathan: Let's simplify the description and sent out a call for volunteers.

 - a) (Standing Item): 2021 Legislative Session

Marco: As a primer for the 2021 Legislative Session and general update on bills so far; A couple of planning-related bills that will directly impact us:

- Electronic plan submission (Assembly Bill 3)
- Revising of the revisions of PUD law (sponsored bill)
- Revisions regarding governing districts (will have a direct impact to NRS278)
- Revisions regarding governing of urban planning and public health

I will continue to update as things progress.

b) For possible Action: Discussion on portion of NV APA budget to be apportioned for financial relief for APA membership to individuals related to hardship due to COVID-19 pandemic (submitted by Lorenzo Mastino).

Lorenzo: We have been discussing financial relief to members for fees, related to COVID hardships. I sent out a two-page summary with requirements and the process to request financial aid. This is for Nevada Chapter fees only (National does provide other relief programs). I asked for thoughts or changes.

Nathan: It looks great. Thank you for putting it together.

Jared: We may want to specify that we are waiving the \$40 Chapter-only membership fee, and I would suggest we include the membership form which includes the specified dates.

Nathan: Let's add a link for National's membership assistance options.

Lorenzo moved to approve the Nevada Chapter Membership COVID Relief program draft. Garrett seconded that. [Approved unanimously. Motion Passed]
