- Continued updates on the 2021 Legislative session; will provide updates as we approach April legislative deadlines.

- Northern Section Report (Events, Treasurer's Report) (submitted by Frederick Steinmann).

- The NVAPA Northern Section continues to work on developing elements of the 2021 Annual Conference. The Northern Section is currently surveying members of the NVAPA in order to gauge overall support for four different conference formats: (1) a full 2 1/2 day in-person conference, (2) a shortened 1 1/2 day in- person conference, (3) a mix inperson and online/virtual conference, and (4) a full online/virtual conference. The results of this membership survey will be completed by early April. Tentatively the Northern Section is planning a full 2 1/2 day conference for Monday, October 18, 2021, Tuesday, October 19, 2021 and Wednesday, October 20, 2021. A final decision regarding the format of the conference will be made by June 1, 2021. The Northern Section is also preparing two upcoming online educational luncheons, one for Wednesday, April 7, 2021 and one for Wednesday, April 28, 2021.

• Southern Section Report (Events, Treasurer's Report) (submitted by Garrett TerBerg).

Garrett: The first Southern Section Activity was held March 2nd [2021] covering the Comprehensive Master Planning Process/Live-Work Zoom Session. It was a great success with Members from around Nevada in attendance. Questions were fielded from the attendees and the recorded session is posted on the Nevada Chapter YouTube Channel.

Another activity tentatively planned for June 2021 is an online informational wrap up of the NV Legislative Session.

Conference Committee

Fred: The Northern Section is making progress. Planning the conference for October 18, 19, and 20 at the Reno Ballroom and National Bowling Stadium.

Summary of Member Survey: Options for conferences (2 options). We received 75 responses (about 1/3 of requests sent out). 100% online conference had the least support. We are likely to move forward on a full in-person 2.5-day conference. A hybrid would present some challenges. We'll continue to work out details based on COVID events. We're considering discounts for those unable to attend in-person. Amber will be handling awards (planning to collaborate with Georgia APA, could use some help encouraging people to submit for awards, will be free - no charge anymore).

Aric: We have been looking at Utah APA, AIA, ASLA, Southern NV Building Assoc, etc. and have come up with listserv - east to monitor, less than \$100/year. Can be used for sharing info, event info, Chapter business, etc. The group would take on for first year, then possibly each organization will manage for a year at a time.
